

PRIVACY NOTICE

Under Article 13 of Regulation (EU) 2016/679 on the protection of individuals regarding the processing of personal data (hereinafter "GDPR")

Dear User,
Please take a moment to read our privacy notice.

1. Data Controller

The Data Controller of the website "InnovHub" is **Chiesi Italia S.p.A.** with registered office in Via Giacomo Chiesi, 1 – 43122 Parma ("Chiesi"), Italy, (hereinafter "**Chiesi**" or "Data Controller"), which you may contact for any information or requests regarding the use of cookies and similar technologies on this Site.

2. Personal Data

Your biographical data and your contact information (first name, last name, e-mail address).

3. Purpose

Your personal data will be processed for:

- registration to the InnovHub;
- access to the restricted part;
- possibility of making applications in the manner described in the InnovHub's website;
- contacting you.

4. Legal basis and nature of the Processing

Your personal data will be processed subject to your consent. Without your consent, it will not be possible to proceed with the uploading of the pitch.

5. Recipients of the Processing

Your personal data are accessible to our authorized personnel on a need-to-know basis and may be disclosed to third parties where required by applicable laws and/or regulations.

Your personal data may also be shared with system administrators and website managers.

6. Transfer of your personal data

Personal data is mainly processed within the European Union.

For some services we use tools (e.g. Google Inc.,) from companies with registered offices in the United States of America and adherents of the Privacy Shield, which ensures that the processing of personal data is in line with European data protection legislation.

7. Retention period of your personal data

Please be advised that where the retention of your personal data is required to fulfill legal obligations, Chiesi will comply with the relevant required retention periods.

In other cases, Chiesi will retain your data for the period considered strictly necessary to achieve the purposes listed above.

8. Rights of the data subject

- **Right of access**, which is the right to obtain confirmation from Chiesi that Data is or is not being processed and, if so, to obtain access to it;
- **Right to rectification and to be forgotten**, which is the right to obtain rectification of inaccurate Data and/or supplementation of incomplete Data or deletion of Data for legitimate reasons;
- **Right to restrict processing**, which is the right to request suspension of processing if there are legitimate reasons;
- **Right to data portability**, which is the right to receive in a structured, commonly used and readable format the Data, as well as the right to transmit the Data to another data controller;
- **Right to object to processing**, which is the right to object to the processing of the Data if there are legitimate reasons for doing so;
- **Right to appeal to the competent data protection authority** in case of unlawful processing of Data.

The above rights may be exercised by making a request to Chiesi's Data Protection Officer at dpochiesiitalia@chiesi.com without formalities at any time. Appropriate feedback will be provided to such a request without delay and in any case no longer than 30 days after its receipt, with the exception of cases of major complexity or in the case of a large number of requests received, where this period may be extended by an additional 2 months.

9. Modalities of Processing

The data collected are processed mainly by computer tools.

In any case, the logical and physical security of the data and, in general, the confidentiality of the processed personal data will be ensured, putting in place all necessary technical and organizational measures adequate to ensure their security.

10. Updates

This notice may be updated from time to time. Any update to this notice will become effective at the time of its publication on the Website.
